REGULAR MEETING OF SEPTEMBER 17, 2019

It was announced that the requirements of R.S. 10:4-18 has been satisfied by the publication of the required advertisement in the Coaster and in the Asbury Park Press on April 5, 2019, posted on the bulletin board in the Central Office of the Housing Authority of the Township of Neptune and filing said notice with the Municipal Clerk of the Township of Neptune. In case of a fire, the stairways to the right and left will be utilized as our emergency exits.

Minutes:

Committee Reports:

Commissioner Vuono read the highlights of the operations reports that were submitted into the record.

Chairperson Holland stated there was a finance meeting earlier in the day with the Authority's Accountant Dave Ciarrocca, who was also in attendance to discuss and answer any questions pertaining to the TNHA finances and Budget proposals. He would also go onto present the years Write-offs along with the State Budget and Operating Budget. Chairperson Holland asked the accountant Dave Ciarrocca for the highlights of the meeting. Mr. Ciarrocca reviewed TNHA financial wherewithal of the agency's finances and the October 1, 2019 to September 30, 2020 budget and the steps taken to prepare and submit said budget. He went on to explain the capital fund; how it's managed, the increases in the past two years and invited any questions the board might have.

Correspondence:

New Business:

The Personnel Committee of the TNHA has reviewed the salary of the current Housing Authority salaried employees and received recommendations for an increase, and whereas with careful deliberation reviewed TNHA finances and agreed to a 3% increase to their base salary. A resolution approving all salaried employees of the TNHA shall receive a 3% increase to their base salary was offered by Commissioner Wright and seconded by Commissioner Griggs, the "Ayes" and "Nays" were as follows:

The Personnel Committee of the TNHA has reviewed the salary of the current Housing Authority Executive Director, and whereas with careful deliberation reviewed TNHA finances and agreed to a 3% increase to his base salary as of October 1, 2019. There will be no increase to the Executive Directors auto allowance or to the management pay from Neptune City Housing Authority at this time. A resolution approving a 3% increase to the Executive Directors base pay was offered by Commissioner Vuono and seconded by Commissioner Wright, the "Ayes" and "Nays" were as follows:

The Authority had passed Resolution #2057 rejecting additional "Shortfall" Funding from HUD for the Section 8 Housing Assistance Subsidy FYE December 31, 2019. The Authority has determined that a moratorium on Section 8 lease ups would result in long-term permanent reduction of the Section 8 program. A resolution was offered to rescind Resolution # 2057 and request additional "Shortfall" from HUD for the Section 8 Housing Assistance Subsidy for year ending December 31, 2019 by Commissioner Griggs and seconded by Commissioner Foster, the "Ayes" and "Nays" were as follows:

Public Portion:

Brenda Shuler, of 30 Ridge Court Apt. #60 addressed the board stated the maintenance men do a great job cleaning up the trash residents leave around the property. Ms. Shuler would like residents to be more responsible when throwing out their trash and we the Authority should make them more accountable. Mr. Cook and the Commissioners agreed to send a letter out to the residents that explain our policy and procedures that refer to the littering on property grounds and proper trash disposal.

Kathy Degraffinreadt, of 1824 Alberta Avenue, Apt. #56 addressed the board stating she asked to be placed on the transfer list last month and wants to know why she hasn't been moved yet. Mr. Cook stated the transfer list is very long and although you are on the list does not mean you are moved immediately. Mr. Cook went onto explain the process of the transfer list in more detail.

Linda Johnson of Neptune addressed the board where we were with converting to RAD, Mr. Cook responded, it is a long process and we are progressing nicely.

EXECUTIVE SESSION:
