RESOLUTION OF THE HOUSING AUTHORITY OF THE TOWNSHIP OF NEPTUNE APPROVAL OF THE DEFINITION OF A SIGNIFICANT AMENDMENT AND SUBSTANTIAL DEVIATION/MODIFICATION OF THE 5 YEAR AND ANNUAL PLAN

A Significant Amendment is defined as a discretionary change in the plan or policies of the Housing Authority that fundamentally changes the Authority and which by its nature requires the Board of Commissioners' Approval
