**To Approve an agreement between the Neptune Housing Development Corporation, 501 C3 and Township of Neptune Housing Authority regarding Laundry Room and Social Room Facilities**

**Whereas** the Township of Neptune Housing Development Corp. (hereinafter "NHDC") has an on-going business relationship with the Township of Neptune Housing Authority (hereinafter "TNHA"); and

**Whereas** the parties agree the TNHA has and will continue providing laundry room facilities and social room facilities for usage fees; and

**Whereas** the NHDC agrees they will maintain, and repair (when needed) said facilities; and

**Whereas** the TNHA will ensure that personnel from the TNHA is not utilized to perform services for said facilities during regular working hours while being compensated by the TNHA ; and

**Whereas** the parties agree that in the event that TNHA personnel is utilized to perform effort for the NHDC during their normal working hours for work, the NHDC said effort must be computed and reimbursed to the TNHA; and

**Whereas** the parties agree that the NHDC shall continue to receive funds generated and collected from said facilities; and

Whereas either party may withdraw from this agreement at any time upon written notice to the other party with (60) sixty days' notice; and

**Now Therefore Be It Resolved** the Township of Neptune Board of Commissioners approve the agreement between the Neptune Housing Development Corporation, 501 C3 and Township of Neptune Housing Authority regarding Laundry Room and Social Room Facilities
